Proposal 2

Generic Rule 3(b) be amended to:

For the 2021/22 season if a Club withdraws any entry(s) in any league once the entries have been received and discussed at the LLB meeting following the closing date, then that Club, provided they advise of any change to their entry(s) **BY** the 1st September, their entries for the following season will not be affected. Changes made to entries **after** 1st September, then that Club should not be allowed to enter more sides than they played in the current season in the following season.

Proposal 3 - Generic Rule 3(b) be amended to -

During the 2021/22 season any Club who have to withdraw a side from the South Alicante or Southern Leagues, as a consequence of the implications on their Club as a direct result of Brexit or the Covid virus, should not be penalised in any way.

Proposal 4 - Generic Rule 6 be amended to -

In the event of any Club having to withdraw a side from either league, any player who has played in the side being withdrawn will be eligible to play for another side from the Club during the season.

Proposal 5 - Appendix B Item (5) Southern League San Miguel agreed that the points for requesting this need not be read out and included.

Before voting took place comments were raised although all club reps present had their agreed vote from their club:

- i) Southern League co-ordinator - if agreed this could possibly open doors for other clubs to do like wise in order to avoid playing on a Friday afternoon. Other clubs may not wish/be able to play on a Thursday morning due to other commitments. Results being submitted on Thursday I may not be available that evening to acknowledge them which could create a problem.
- ii) La Marina said this has been raised so many times before and been declined as had La Manga wishing to play on a Tuesday.

San Miguel BC request they be allowed to have a side playing their home matches in the Southern League on a Thursday morning before the scheduled Friday. This would mean that, for each club in the affected league, one away match only per season would be played on a Thursday morning.
