1. Welcome and Apologies

Apologies received from Steve Blacklaw, Peter Matthews and Sandra Heath

Proposal 1

I refer to the Membership section of the LLB Constitution as it stands at the moment with 2(c) being the critical part.

It seems that technically the annual affiliation fee is the **application/acceptance** to join the LLB just as the league entry fee is the application/acceptance to join that league.

So when a club comes to pay its affiliation fee and has NO premises of its own Item 2(c) as currently written could be regarded by some as a problem that the proposal carried at the LLB AGM does not really solve.

Modified wording of Statute 2 c) Including words – INITIALLY

c) A Club, at the time of being **INITIALLY** accepted as a member of the LLB, must have its own premises on which to play inter club events, tournaments, leagues etc. Should during a season, the club's premises not be available they may, with the consent of the LLB committee, approach another club(s) to use their premises to fulfil their outstanding fixtures. They may only commit themselves to future inter club activities provided assurance can be given that alternative premises are available.

Proposal 2

Rationale:

To update the current Generic Rules, Appendices and conditions of play for ALL LLB events, which served a purpose but have been bastardised yearly for the last 13 Years, and are in need of updating.

Proposal:

The LLB Form a "Match Committee" which will act as a sub-committee of the LLB, their role will be to ensure the Rules and COP's are kept up to date and provide a solid platform for all bowls within the LLB to function. Match

Committee to compromise the following

Winter League Co-ordinator
Southern League Co-ordinator
Northern League Co-ordinator
SABA Summer Co-ordinator
SABA Winter Co-ordinator

This “Match Committee” will then, for the purpose of ALL LLB Competitions (leagues & knockouts), become the “Controlling Body” and all decisions made will be final.

Yearly at the AGM or at any EGM the Match Committee may propose NEW or ALTERED playing conditions which will need to be voted on by the members of the LLB.
